ORDER OF REVOCATION

THIS PROCEEDING CAME on for final agency action and the Chief Financial Officer, having considered the record, including the Administrative Complaint filed on December 8, 2014, and being fully advised in the premises, finds that:

- 1. Gerald Leroy Jenkins is currently licensed by the Department of Financial Services (the "Department"), pursuant to the Florida Insurance Code, as a limited surety (bail bond) agent. This license is currently suspended pursuant to a Notice of Temporary Suspension.
- 2. On December 8, 2014, the Department issued an Administrative Complaint, attached hereto as "Exhibit A," against Gerald Leroy Jenkins, alleging that on September 10, 2014, in the Circuit Court for the Twentieth Judicial Circuit, in and for Lee County, Case No. 13-CF-19572, he pled no contest to four counts of Possession of Cocaine and four counts of Cocaine Sale within 1000 Feet of Specified Area, all felonies. He was adjudicated guilty.
- 3. The Department notified Gerald Leroy Jenkins in the Administrative Complaint of the right to request a proceeding in accordance with sections 120.569 and 120.57, Florida

Statutes, and that failure to answer the Administrative Complaint or request a proceeding within twenty-one (21) days would result in the imposition of a penalty.

- 4. In accordance with section 624.310(6), Florida Statutes, the Administrative Complaint was served upon Gerald Leroy Jenkins on February 2, 2015, by personal service, in Suwannee County, Florida, by Jeffery L. Young, the Department's investigator.
- 5. Gerald Leroy Jenkins failed to answer the Administrative Complaint or request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes.

FINDINGS OF FACT

6. The factual allegations contained in the Administrative Complaint dated December 8, 2014, which is attached hereto as Exhibit A, and fully incorporated herein by reference, are hereby adopted as the Department's Findings of Fact in this case.

CONCLUSIONS OF LAW

7. Based upon the Findings of Fact adopted herein, the Department concludes that Gerald Leroy Jenkins violated the specific statutes and rules charged in each count of the Administrative Complaint, attached hereto as Exhibit A, and hereby adopts the violations charged in each count of the Administrative Complaint as the Conclusions of Law in this case.


PENALTY IMPOSED

8. The failure of Gerald Leroy Jenkins to answer the Administrative Complaint or request a proceeding, taken together with the Findings of Fact and Conclusions of Law adopted herein, constitutes grounds for the Chief Financial Officer to revoke the license of Gerald Leroy Jenkins.

IT IS THEREFORE ORDERED that:

- (a) All licenses, appointments and eligibility for licensure heretofore issued to Gerald Leroy Jenkins, within the purview of the Department, are hereby revoked.
- (b) Pursuant to section 648.49(2), Florida Statutes, Gerald Leroy Jenkins does not have the right to apply for another license or appointment under chapter 648, Florida Statutes.
- (c) During the period of revocation of the license the former licensee may not engage in or attempt or profess to engage in any transaction or business for which a license or appointment is required under chapter 648, Florida Statutes.
- (d) Within ten (10) calendar days of the issuance of this Order of Revocation, Gerald Leroy Jenkins shall return all licenses issued to him pursuant to the Florida Insurance Code to the Department of Financial Services, Bureau of Licensing, 200 East Gaines Street, Tallahassee, Florida 32399-0319.
- (e) Any person who knowingly transacts insurance or otherwise engages in insurance activities in this state without a license, or while the license is suspended or revoked, commits a felony of the third degree.



Gerald Leroy Jenkins, license #A130877, is hereby notified that the Chief Financial Officer of the State of Florida has caused to be made an investigation of his activities while licensed as a limited surety (bail bond) agent in this state, as a result of which it is alleged:

GENERAL ALLEGATIONS

- 1. Pursuant to chapter 648, Florida Statutes, Gerald Leroy Jenkins is licensed in this state as a limited surety (bail bond) agent. Gerald Leroy Jenkins' license is currently suspended.
- 2. On April 7, 2014, a Notice of Temporary Suspension was filed against Gerald Leroy Jenkins suspending his license as a limited surety (bail bond) agent.



3. Pursuant to chapter 648, Florida Statutes, the Florida Department of Financial Services (the "Department") has jurisdiction over Gerald Leroy Jenkins's license and eligibility for licensure as a limited surety (bail bond) agent.

COUNT I

- 4. The above general allegations are hereby realleged and fully incorporated herein by reference.
- 5. On September 10, 2014, in the Circuit Court for the Twentieth Judicial Circuit, in and for Lee County, Case No. 13-CF-19572, Gerald Leroy Jenkins pled no contest to four counts of Cocaine Sale within 1000 Feet of Specified Area and four counts of Possession of Cocaine, all felonies. He was adjudicated guilty.

IT IS THEREFORE CHARGED that GERALD LEROY JENKINS has violated one or more of the following provisions of the Florida Statutes and/or the *Florida Administrative Code*, which constitutes sufficient grounds for the revocation of his license or appointment as a limited surety (bail bond) agent in this state:

- (a) Section 648.45(2)(a), Florida Statutes, which provides that the Department shall deny, suspend, revoke, or refuse to renew any license issued under chapter 648, Florida Statutes, or the Insurance Code, if it finds that the licensee lacks one or more of the qualifications for the license or appointment as specified in Chapter 648, Florida Statutes.
- (b) Section 648.34(2)(e), Florida Statutes, which requires a person to be of high character and approved integrity and to have not been convicted of or pleaded guilty or no contest to a felony, a crime involving moral turpitude, or a crime punishable by imprisonment of 1 year or more under the law of any state, territory, or country, whether or not a judgment or

conviction has been entered, in order to qualify for licensure as a limited surety (bail bond) agent.

- (c) Section 648.45(2)(e), Florida Statutes, which provides that the Department shall deny, suspend, revoke, or refuse to renew any license issued under chapter 648, Florida Statutes, or the Insurance Code if the licensee had exhibited a demonstrable lack of fitness or trustworthiness to engage in the limited surety (bail bond) agent business.
- (d) Section 648.45(2)(k), Florida Statutes, which provides that the Department shall deny, suspend, revoke, or refuse to renew any license issued under chapter 648, Florida Statutes, or the Insurance Code if the licensee has been found guilty of, or has pleaded guilty or no contest to a felony, a crime involving moral turpitude, or a crime punishable by imprisonment of one (1) year or more under the law of any state, territory, or country, whether or not a judgment or conviction has been entered.

WHEREFORE, Gerald Leroy Jenkins is hereby notified that the Chief Financial Officer, through his designee, intends to enter an order revoking his license and appointments or to impose such penalties as may be provided under the provisions of sections 648.45, 648.46, 648.49, 648.50, 648.51, 648.52, 648.525, and 648.53, Florida Statutes, and under the other referenced sections of the Florida Statutes as set out in this Administrative Complaint.

NOTICE OF RIGHTS

You have the right to request a proceeding to contest this action by the Department pursuant to sections 120.569 and 120.57, Florida Statutes, and chapter 28-106, *Florida Administrative Code*. The proceeding request must be in writing, signed by you, and must be filed with the Department within twenty-one (21) days of your receipt of this notice. Completion of the attached Election of Proceeding form and a petition for administrative hearing are required. The request must be filed with Julie Jones, DFS Agency Clerk, at the Florida Department of Financial Services, 612 Larson Building, 200 East Gaines Street, Tallahassee, Florida 32399-0390. Your written response must be received by the Department no later than 5:00 p.m. on the twenty-first day after your receipt of this notice. Mailing the response on the twenty-first day will not preserve your right to a hearing.

FAILURE TO ENSURE THAT YOUR WRITTEN RESPONSE IS RECEIVED BY THE DEPARTMENT WITHIN TWENTY-ONE (21) DAYS OF YOUR RECEIPT OF THIS NOTICE WILL CONSTITUTE A WAIVER OF YOUR RIGHT TO REQUEST A PROCEEDING ON THE MATTERS ALLEGED HEREIN AND A FINAL ORDER OF REVOCATION WILL BE ENTERED AGAINST YOU.

If you request a proceeding, you must provide information that complies with the requirements of Rule 28-106.2015, *Florida Administrative Code*. Specifically, your response must contain:

(a) The name, address, telephone number, and facsimile number (if any) of the respondent (for the purpose of requesting a hearing in this matter, you are the "respondent").

- (b) The name, address, telephone number, and facsimile number of the attorney or qualified representative of the respondent (if any) upon whom service of pleadings and other papers shall be made.
- (c) A statement requesting an administrative hearing identifying those material facts that are in dispute. If there are none, the petition must so indicate.
- (d) A statement of when the respondent received notice of the administrative complaint.
 - (e) A statement including the file number of the administrative complaint.

If a hearing of any type is requested, you have the right to be represented by counsel or other qualified representative at your expense, to present evidence and argument, to call and cross-examine witnesses, and to compel the attendance of witnesses and the production of documents by subpoena.

Unless the majority of witnesses are located elsewhere, the Department will request that the hearing be conducted in Tallahassee, Florida.

Failure to follow the procedure outlined with regard to your response to this notice may result in the request being denied. All prior oral communication or correspondence in this matter shall be considered free form agency action, and no such oral communication or correspondence shall operate as a valid request for an administrative proceeding. Any request for an administrative proceeding received before the date of this notice shall be deemed abandoned unless timely renewed in compliance with the guidelines as set out above.

Mediation of this matter pursuant to section 120.573, Florida Statutes, is not available. No Department attorney will discuss this matter with you with during the time frame in which you have to request a hearing.

NOTICE OF TEMPORARY SUSPENSION

COMES NOW the Chief Financial Officer, by and through his named designee, pursuant to Section 648.45(1), Florida Statutes, and issues this Order temporarily suspending all licenses and appointments heretofore issued to GERALD LEROY JENKINS, under Chapter 648, Florida Statutes, and as grounds therefore finds:

- 1. GERALD LEROY JENKINS is currently licensed in this state as a Limited Surety (Bail Bond) Agent pursuant to Chapter 648, Florida Statutes.
- 2. At all times relevant to the dates and occurrences set forth herein, GERALD LEROY JENKINS, License I.D. # A130877, was licensed in this state as a Limited Surety (Bail Bond) Agent.
- 3. On or about August 14, 2013, August 15, 2013, August 20, 2013, and December 5, 2013, GERALD LEROY JENKINS was charged in the was charged in the Circuit Court of the Twentieth Judicial Circuit in and for Lee County, Florida, with the Sale of Cocaine Within 1000 feet of Place of Worship and Possession of Cocaine, felonies.
- 4. Pursuant to Section 648.45(1), Florida Statutes, the Department shall, upon receipt of an information or indictment, immediately temporarily suspend any license or appointment issued under Chapter 648, Florida Statutes, when the licensee has been charged with a felony or a crime involving moral turpitude or a crime punishable by imprisonment of one (1) year or more under the law of any state, territory, or country. Such suspension shall continue

if the licensee has been found guilty of, or has pleaded guilty or no contest to, the crime, whether or not a judgment or conviction has been entered, during a pending appeal. A person may not effect any additional bail bonds after suspension of his license or appointment, however licensee may discharge any liability on bonds effected prior to suspension.

Notice is hereby given that the Department shall take prompt action to revoke the license of GERALD LEROY JENKINS in the event licensee pleads guilty, nolo contendere or is found guilty of this felony or any other lesser offense which is a felony, a crime involving moral turpitude or a crime punishable by imprisonment of one year or more under the law of any state, territory or country whether or not a judgment or conviction has been entered.

WHEREFORE, IT IS HEREBY ORDERED:

- (a) That the Limited Surety (Bail Bond) Agent license held by GERALD LEROY JENKINS is hereby SUSPENDED. During the period of suspension GERALD LEROY JENKINS may not engage in any transaction or business for which a license or appointment is required by Chapter 648, Florida Statutes.
- (b) That GERALD LEROY JENKINS shall immediately cease and desist from writing, issuing, or soliciting any bail bonds in the State of Florida and he shall not effect any additional bail bonds. However, pursuant to Section 648.45(1), Florida Statutes, GERALD LEROY JENKINS may discharge any liability on bonds effected prior to this suspension.


