## ORDER OF REVOCATION

THIS PROCEEDING CAME on for final agency action and the Chief Financial Officer, having considered the record, including the Administrative Complaint filed on September 12, 2014, and being fully advised in the premises, finds that:

1. Ayeodeli Stephen is currently licensed by the Department of Financial Services (the "Department"), pursuant to the Florida Insurance Code, as a general lines agent.
2. On September 12, 2014, the Department issued an Administrative Complaint, attached hereto as "Exhibit A," against Ayeodeli Stephen, alleging that on April 28, 2014, in the Ninth Judicial Circuit, in and for Osceola County, Florida, Case No. CF-140-545 she pled guilty to one count of Possession of Cocaine, a felony. Adjudication of guilt was withheld.
3. The Department notified Ayeodeli Stephen in the Administrative Complaint of the right to request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes, and that failure to answer the Administrative Complaint or request a proceeding within twenty-one (21) days would result in the imposition of a penalty.

4. In accordance with section 624.310(6), Florida Statutes, after attempts at service via certified mail were unsuccessful, the Department served the Administrative Complaint upon Ayeodeli Stephen by e-mail at the e-mail address on record with the Department, with the required delivery receipt received on September 23, 2014. The e-mail, e-mail attachment (Administrative Complaint), and delivery receipt are attached hereto as "Exhibit B," and are fully incorporated herein by reference.

5. Ayeodeli Stephen failed to answer the Administrative Complaint or request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes.

#### FINDINGS OF FACT

6. The factual allegations contained in the Administrative Complaint dated September 12, 2014, which is attached hereto as "Exhibit A," and fully incorporated herein by reference, are hereby adopted as the Department's Findings of Fact in this case.

#### CONCLUSIONS OF LAW

7. Based upon the Findings of Fact adopted herein, the Department concludes that Ayeodeli Stephen violated the specific statutes and rules charged in each count of the Administrative Complaint, attached hereto as "Exhibit A," and hereby adopts the violations charged in each count of the Administrative Complaint as the Conclusions of Law in this case.

#### PENALTY IMPOSED

8. The failure of Ayeodeli Stephen to answer the Administrative Complaint or request a proceeding, taken together with the Findings of Fact and Conclusions of Law adopted herein, constitute grounds for the Chief Financial Officer to revoke the licenses of Ayeodeli Stephen.

IT IS THEREFORE ORDERED that:

(a) All licenses, appointments and eligibility for licensure heretofore issued to Ayeodeli Stephen, within the purview of the Department, are hereby REVOKED.

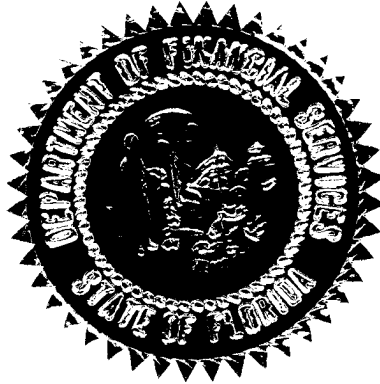
(b) Ayeodeli Stephen does not have the right to apply for another license or appointment under the Florida Insurance Code for a period of two (2) years after the effective date of revocation. The Department shall not thereafter grant Ayeodeli Stephen a new license or appointment or reinstate eligibility to hold such license or appointment if it finds that the circumstance or circumstances for which the license was revoked still exist or are likely to recur.

(c) During the period of revocation, Ayeodeli Stephen shall not engage in or attempt or profess to engage in any transaction or business for which a license or appointment is required under the Insurance Code or directly or indirectly own, control, or be employed in any manner by any insurance agent or agency or adjuster or adjusting firm until the license is reinstated or, if revoked, a new license is issued.

(d) Within ten (10) calendar days of the issuance of this Order of Revocation, Ayeodeli Stephen shall return all licenses issued to Ayeodeli Stephen pursuant to the Florida Insurance Code to the Department of Financial Services, Bureau of Licensing, 200 East Gaines Street, Tallahassee, Florida 32399-0319.

(e) Any person who knowingly transacts insurance or otherwise engages in insurance activities in this state without a license, or while the license is suspended or revoked, commits a felony of the third degree.

## NOTICE OF RIGHTS

Any party to these proceedings adversely affected by this Order is entitled to seek review within thirty (30) days of the rendition of this Order, pursuant to section 120.68, Florida Statutes, and Rule 9.190, *Florida Rules of Appellate Procedure*. Review proceedings must be instituted by filing a petition or notice of appeal with Julie Jones, the DFS Agency Clerk. Filing with the Agency Clerk may be accomplished via U.S. Mail, express overnight delivery, hand delivery, facsimile transmission, or electronic mail. Ayeodeli Stephen, license I.D. # P228497, is hereby notified that the Chief Financial Officer of the State of Florida has caused to be made an investigation of her activities while licensed as an insurance agent in this state, as a result of which it is alleged:

GENERAL ALLEGATIONS

1. Pursuant to chapter 626, Florida Statutes, Ayeodeli Stephen is currently licensed in this state as a general lines agent.
2. At all times pertinent to the dates and occurrences referred to herein, Ayeodeli Stephen was licensed in this state as a general lines agent.
3. Pursuant to chapter 626, Florida Statutes, the Florida Department of Financial Services (the "Department") has jurisdiction over her insurance license and appointments.

COUNT I

4. The above general allegations are hereby realleged and fully incorporated herein by reference.



5. On April 28, 2014, in the Circuit Court of the Ninth Judicial Circuit in and for Osceola County, Florida, Case No. CF140-545, Ayeodeli Stephen pled guilty to one count of Possession of Cocaine, a felony. Adjudication of guilt was withheld.

IT IS THEREFORE CHARGED that Ayeodeli Stephen has violated one or more of the following provisions of the Florida Statutes or *Florida Administrative Code*, which constitute grounds for the suspension or revocation of her license as a general lines agent in this state:

(a) Section 626.621(8), Florida Statutes, which provides that it is a violation to be found guilty of or to plea guilty or nolo contendere to a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country, without regard to whether a judgment of conviction has been entered by the court having jurisdiction of such cases.


(b) Rule 69B-231.150, *Florida Administrative Code*, which provides that while licensed by the Department, if a licensee is convicted of, or been found guilty of or has pled guilty or nolo contendere (no contest) to, a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country, regardless of adjudication, the penalty shall be revocation of all licenses and appointments held by the licensee.



WHEREFORE Ayeodeli Stephen is hereby notified that the Chief Financial Officer intends to enter an Order revoking her license and appointment as an insurance agent or to impose such penalties as may be provided under the provisions of sections 626.611, 626.621, 626.641, 626.681, 626.691, and 626.9521, Florida Statutes, Rule 69B-231.150, *Florida Administrative Code*, and under the other referenced sections of the Florida Statutes as set out in this Administrative Complaint.

### NOTICE OF RIGHTS

Ayeodeli Stephen has the right to request a proceeding to contest this action by the Department pursuant to sections 120.569 and 120.57, Florida Statutes, and Rule 28-106, *Florida Administrative Code*. The proceeding request must be in writing, signed by Ayeodeli Stephen, and must be filed with the Department within twenty-one (21) days of her receipt of this notice. Completion of the attached Election of Proceeding form and/or a petition for administrative hearing will suffice as a written request. The request must be filed with Julie Jones, DFS Agency Clerk, at the Florida Department of Financial Services, 612 Larson Building, 200 East Gaines Street, Tallahassee, Florida 32399-0390. Ayeodeli Stephen's written response must be received by the Department no later than 5:00 p.m. on the twenty-first day after her receipt of this notice. Mailing the response on the twenty-first day will not preserve her right to a hearing.

**FAILURE TO ENSURE THAT AYEODELI STEPHEN  
WRITTEN RESPONSE IS RECEIVED BY THE  
DEPARTMENT WITHIN TWENTY-ONE (21) DAYS OF  
HER RECEIPT OF THIS NOTICE WILL CONSTITUTE A  
WAIVER OF HER RIGHT TO REQUEST A PROCEEDING  
ON THE MATTERS ALLEGED HEREIN AND A FINAL  
ORDER OF REVOCATION WILL BE ENTERED AGAINST  
HER.**

If Ayeodeli Stephen requests a proceeding, then she must provide information that complies with the requirements of Rule 28-106.2015, *Florida Administrative Code*. As noted above, completion of the attached Election of Proceeding form conforms to these requirements. Specifically, her response must contain:

(a) The name, address, and telephone number, and facsimile number (if any) of the respondent (for the purpose of requesting a hearing in this matter, Ayeodeli Stephen is the "respondent").

(b) The name, address, telephone number, facsimile number of the attorney or qualified representative of the respondent (if any) upon whom service of pleadings and other papers shall be made.

(c) A statement requesting an administrative hearing identifying those material facts that are in dispute. If there are none, the petition must so indicate.

(d) A statement of when the respondent received notice of the administrative complaint.

(e) A statement including the file number of the administrative complaint.

If a hearing of any type is requested, Ayeodeli Stephen has the right to be represented by counsel or other qualified representative at her expense, to present evidence and argument, to call and cross-examine witnesses, and to compel the attendance of witnesses and the production of documents by subpoena.

If a proceeding is requested and there is no dispute of material fact, the provisions of section 120.57(2), Florida Statutes, apply. In this regard, Ayeodeli Stephen may submit oral or written evidence in opposition to the action taken by the Department or a written statement challenging the grounds upon which the Department has relied. While a hearing is normally not required in the absence of a dispute of fact, if Ayeodeli Stephen feels that a hearing is necessary, one will be conducted in Tallahassee, Florida, or by telephonic conference call upon her request.

However, if Ayeodeli Stephen disputes material facts which are the basis for the Department's action, she must request an adversarial proceeding pursuant to sections 120.569 and 120.57(1), Florida Statutes. These proceedings are held before a State Administrative Law Judge of the Division of Administrative Hearings. Unless the majority of witnesses are located elsewhere, the Department will request that the hearing be conducted in Tallahassee, Florida.

Failure to follow the procedure outlined with regard to Ayeodeli Stephen's response to this notice may result in the request being denied. All prior oral communication or correspondence in this matter shall be considered free form agency action, and no such oral communication or correspondence shall operate as a valid request for an administrative proceeding. Any request for an administrative proceeding received prior to the date of this notice shall be deemed abandoned unless timely renewed in compliance with the guidelines as set out above.

Mediation of this matter pursuant to section 120.573, Florida Statutes, is not available. No Department attorney will discuss this matter with Ayeodeli Stephen until the response has been received by the Department.
