CONSENT ORDER

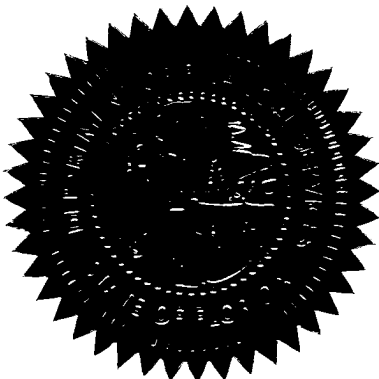

Upon his approval and without further notice the Chief Financial Officer or his designee may issue a Consent Order, which will incorporate, by reference of, all the terms and conditions of this Field Office Settlement Stipulation.

Failure to pay the administrative fine within thirty (30) days of the issuance of the Consent Order shall result in the immediate suspension of your license(s) and eligibility for licensure in this state without further proceedings for a period of thirty (30) days. If you are suspended for violating the FOSS for Consent Order or the Consent Order to be entered in this cause, including payment of the administrative fine, you shall, at the end of the applicable period(s) of suspension, be entitled to file an application for reinstatement of licensure. However, your license shall not be reinstated if the Department finds that the circumstance or circumstances for which the license was suspended still exist or are likely to recur, or if you are not otherwise eligible for licensure.
