ORDER OF REVOCATION

THIS PROCEEDING CAME on for final agency action and the Chief Financial Officer, having considered the record, including the Administrative Complaint filed on November 13, 2014, and being fully advised in the premises, finds that:

1. Tracy Linette Robles is currently licensed by the Department of Financial Services (the "Department"), pursuant to the Florida Insurance Code, as a life including variable annuity agent and a customer representative. These licenses are currently suspended per a Notice of Temporary Suspension filed on November 13, 2014.

2. On November 13, 2014, the Department issued an Administrative Complaint, attached hereto as "Exhibit A," against Tracy Linette Robles, alleging that on August 13, 2014, in the Sixth Judicial Circuit Court in and for Pasco County, Florida, Case No. 1304789CFAES, she pled guilty to one count of Welfare Fraud, a felony. She was sentenced to five (5) years probation, ordered to make restitution to the Department of Children and Families in the amount of \$35,357.60, and ordered to pay court costs. Adjudication of guilt was withheld.

3. The Department notified Tracy Linette Robles in the Administrative Complaint of the right to request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes, and that failure to answer the Administrative Complaint or request a proceeding within twenty-one (21) days would result in the imposition of a penalty.

4. In accordance with section 624.310(6)(a), Florida Statutes, after attempts at service via certified mail were unsuccessful, the Department served the Administrative Complaint upon Tracy Linette Robles by e-mail at the e-mail address on record with the Department, with the required delivery receipt received on December 10, 2014. The e-mail, e-mail attachment (Administrative Complaint), and delivery receipt are attached hereto as "Exhibit B," and are fully incorporated herein by reference.

5. Tracy Linette Robles failed to answer the Administrative Complaint or request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes.

FINDINGS OF FACT

6. The factual allegations contained in the Administrative Complaint dated November 13, 2014, which is attached hereto as Exhibit A, and fully incorporated herein by reference, are hereby adopted as the Department's Findings of Fact in this case.

CONCLUSIONS OF LAW

7. Based upon the Findings of Fact adopted herein, the Department concludes that Tracy Linette Robles violated the specific statutes and rules charged in each count of the Administrative Complaint, attached hereto as Exhibit A, and hereby adopts the violations charged in each count of the Administrative Complaint as the Conclusions of Law in this case.

PENALTY IMPOSED

8. The failure of Tracy Linette Robles to answer the Administrative Complaint or request a proceeding, taken together with the Findings of Fact and Conclusions of Law adopted herein, constitutes grounds for the Chief Financial Officer to revoke the licenses of Tracy Linette Robles.

IT IS THEREFORE ORDERED that:

(a) All licenses, appointments and eligibility for licensure heretofore issued to Tracy Linette Robles, within the purview of the Department, are hereby revoked.

(b) Tracy Linette Robles does not have the right to apply for another license or appointment under the Florida Insurance Code for a period of two (2) years from the effective date of revocation. The Department shall not thereafter grant Tracy Linette Robles a new license or appointment or reinstate eligibility to hold such license or appointment if it finds that the circumstance or circumstances for which the license was revoked still exist or are likely to recur.

(c) During the period of revocation, Tracy Linette Robles shall not engage in or attempt or profess to engage in any transaction or business for which a license or appointment is required under the Florida Insurance Code or directly or indirectly own, control, or be employed in any manner by any insurance agent or agency or adjuster or adjusting firm until the license is reinstated or, if revoked, a new license is issued.

(d) Within ten (10) calendar days of the issuance of this Order of Revocation, Tracy Linette Robles shall return all licenses issued to Tracy Linette Robles pursuant to the Florida Insurance Code to the Department of Financial Services, Bureau of Licensing, 200 East Gaines Street, Tallahassee, Florida 32399-0319.

(e) Any person who knowingly transacts insurance or otherwise engages in insurance activities in this state without a license, or while the license is suspended or revoked, commits a felony of the third degree.

Tracy Linette Robles, license #E064847, is hereby notified that the Chief Financial Officer of the State of Florida has caused to be made an investigation of her activities while licensed as an insurance agent in this state, as a result of which it is alleged:

GENERAL ALLEGATIONS

1. Pursuant to chapter 626, Florida Statutes, Tracy Linette Robles is currently licensed in this state as a life including variable annuity agent, and as a customer representative.

2. At all times pertinent to the dates and occurrences referred to herein, Tracy Linette Robles was licensed in this state as a life including variable annuity agent, and as a customer representative.

EXHIBIT

3. Pursuant to chapter 626, Florida Statutes, the Florida Department of Financial Services (the "Department") has jurisdiction over Tracy Linette Robles' insurance licenses and appointments.

COUNT I

4. The above general allegations are hereby realleged and fully incorporated herein by reference.

5. On August 13, 2014, in the Sixth Judicial Circuit Court in and for Pasco County, Florida, Case No. 1304789CFAES, Tracy Linette Robles pled guilty to one count of welfare fraud, a felony. Robles was placed on five (5) year probation, ordered to make restitution to the Department of Children and Families in the amount of \$35,357.60, and ordered to pay court costs. Adjudication of guilt was withheld.

IT IS THEREFORE CHARGED that Tracy Linette Robles has violated one or more of the following provisions of the Florida Statutes or *Florida Administrative Code*, which constitute grounds for the suspension or revocation of her license as a life including variable annuity agent and a customer representative in this state:

(a) Section 626.611(1)(n), Florida Statutes, which provides that it is a violation for any applicant, agent, title agency, adjuster, customer representative, service representative, or managing general agent to be found guilty of or to enter a plea of guilty or nolo contendere to a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country which involves moral turpitude, without regard to whether a judgment or conviction has been entered by the court having jurisdiction of such cases.

(b) Section 626.621(8), Florida Statutes, which provides that it is a violation to be found guilty of or to plea guilty or nolo contendere to a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country, without regard to whether a judgment of conviction has been entered by the court having jurisdiction of such cases.

WHEREFORE, Tracy Linette Robles is hereby notified that the Chief Financial Officer intends to enter an Order revoking her license and appointments as an insurance agent or to impose such penalties as may be provided under the provisions of sections 626.611, 626.621, 626.641, 626.681, 626.691, and 626.9521, Florida Statutes, and under the other referenced sections of the Florida Statutes as set out in this Administrative Complaint.



NOTICE OF TEMPORARY SUSPENSION

COMES NOW the Chief Financial Officer, by and through his named designee, pursuant to section 626.611(2), Florida Statutes, and issues this Order temporarily suspending all licenses and appointments heretofore issued to Tracy Linette Robles, under chapter 626, Florida Statutes, and as grounds therefore finds:

1. Tracy Linette Robles is currently licensed in this state as a life including variable annuity agent and as a customer representative pursuant to chapter 626, Florida Statutes.

2. At all times relevant to the dates and occurrences set forth herein, Tracy Linette Robles was licensed in this state as a life including variable annuity agent and as a customer representative.

3. On July 23, 2013, in the Sixth Judicial Circuit in and for Pasco County, Florida, Case No. 1304789CFAES, an Information was filed against Tracy Linette Robles charging her with Welfare Fraud, a felony.

4. On August 13, 2014, in the Sixth Judicial Circuit Court in and for Pasco County, Florida, Case No. 1304789CFAES, Tracy Linette Robles pled guilty to one count of Welfare Fraud, a felony. Adjudication of guilt was withheld.

5. Pursuant to section 626.611(2), Florida Statutes:

The department shall, upon receipt of information or an indictment, immediately temporarily suspend a license or appointment issued under this chapter when the licensee is charged with a felony enumerated in s. 626.207(3). Such suspension shall continue if the licensee is found guilty of, or pleads guilty or nolo contendere to, the crime, regardless of whether a judgment or conviction is entered, during a pending appeal. A person may not transact insurance business after suspension of his or her license or appointment.

6. Pursuant to sections 626.207(3) and 626.611(2), Florida Statutes, the Department shall immediately suspend the license of a licensee who was charged with a felony of the first degree, a capital felony, a felony involving money laundering, fraud, or embezzlement, or a felony directly related to the financial services business.

(d) Subject to the prohibitions contained in paragraph (c), Tracy Linette Robles is permitted to remain listed on the corporate records of any insurance agency or adjusting firm on which she was listed as a corporate officer, director, member or owner as of the date of entry of this Notice of Temporary Suspension. Subject to the prohibitions contained in paragraph (c), Tracy Linette Robles is also permitted to remain listed on any financial institution accounts and records of any insurance agency or adjusting firm on which she was listed as a corporate officer, director, member or owner as of the date of entry of this Notice of Temporary Suspension.

(e) Any person who knowingly transacts insurance or otherwise engages in insurance activities in this state without a license, or while the license(s) is suspended or revoked, commits a felony of the third degree.
