ORDER OF SUSPENSION

THIS PROCEEDING CAME on for final agency action and the Chief Financial Officer, having considered the record, including the Administrative Complaint filed on October 29, 2014, and being fully advised in the premises, finds that:

- 1. Lawrence Marc Yucht is currently licensed by the Department of Financial Services (the "Department"), pursuant to the Florida Insurance Code, as a public adjuster.
- 2. On October 29, 2014, the Department issued an Administrative Complaint, attached hereto as "Exhibit A", against Lawrence Marc Yucht alleging that he failed to maintain a surety bond.
- 3. The Department notified Lawrence Marc Yucht in the Administrative Complaint of the right to request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes, and that failure to answer the Administrative Complaint or request a proceeding within twenty-one (21) days would result in the imposition of a penalty.

- 4. In accordance with section 120.60(5), Florida Statutes, the Administrative Complaint was served upon Lawrence Marc Yucht by personal service, in Deerfield Beach, Florida, by the Department's investigator, Christopher McGuire, on December 5, 2014.
- 5. On December 23, 2014, the Department received the Election of Proceeding form from Lawrence Marc Yucht which indicated that he did not dispute the Department's factual allegations or request a hearing in a accordance with sections 120.569 and 120.57, Florida Statutes.

FINDINGS OF FACT

6. The factual allegations contained in the Administrative Complaint filed on October 29, 2014, which is attached hereto as Exhibit A, and fully incorporated herein by reference, are hereby adopted as the Department's Findings of Fact in this case.

CONCLUSION OF LAW

7. Based upon the Findings of Fact adopted herein, the Department concludes that Lawrence Marc Yucht violated the specific statutes and rules charged in each count of the Administrative Complaint, attached hereto as Exhibit A, and hereby adopts the violations charged in each count of the Administrative Complaint as the Conclusions of Law in this case.

PENALTY IMPOSED

8. Lawrence Marc Yuchts failure to dispute the Department's factual allegations or request a hearing taken together with the Findings of Fact and Conclusions of Law adopted herein, constitutes grounds for the Chief Financial Officer to suspend the license of Lawrence Marc Yucht.

IT IS THEREFORE ORDERED that:

- (a) All licenses, appointments and eligibility for licensure heretofore issued to Lawrence Marc Yucht, within the purview of the Department, are hereby suspended for a period of ninety (90) days.
- (b) During the period of suspension, Lawrence Marc Yucht shall not engage in or attempt or profess to engage in any transaction or business for which a license or appointment is required under the Florida Insurance Code or directly or indirectly own, control, or be employed in any manner by any insurance agent or agency or adjuster or adjusting firm until the license is reinstated or, if revoked, a new license is issued.
- (b) Lawrence Marc Yucht shall not have the right to apply for and the Department shall not grant another license or appointment under the Florida Insurance Code during the ninety (90) day suspension period. The Department shall not grant Lawrence Marc Yucht a new license or appointment or reinstate eligibility to hold such license or appointment if it finds that a replacement surety bond has not been obtained.
- (d) Following the ninety (90) day suspension, Lawrence Marc Yucht shall be entitled to file for an application for reinstatement of licensure. However, the license of Lawrence Marc Yucht shall not be reinstated if the circumstance or circumstances for which the license was suspended still exist or are likely to recur, or if he is not otherwise eligible for licensure.
- (e) Within ten (10) calendar days of the issuance of this Order of Suspension, Lawrence Marc Yucht shall return to the Department of Financial Services, Attention: Bureau of Licensing, 200 East Gaines Street, Tallahassee, Florida 32399-0319, all licenses issued to Lawrence Marc Yucht pursuant to the Florida Insurance Code.

(f) Any person who knowingly transacts insurance or otherwise engages in insurance activities in this state without a license, or while the license is suspended or revoked, commits a felony of the third degree.

NOTICE OF RIGHT TO APPEAL

ADMINISTRATIVE COMPLAINT

The Chief Financial Officer of the State of Florida has caused to be made an investigation of Lawrence Marc Yucht's activities while licensed as a public adjuster in this state, as a result of which it is alleged:

GENERAL ALLEGATIONS

- 1. Pursuant to chapter 626, Florida Statutes, Lawrence Marc Yucht is currently licensed in this state as a public adjuster.
- 2. At all times pertinent to the dates and occurrences referred to herein, Lawrence Marc Yucht was licensed in this state as a public adjuster.
- 3. Pursuant to chapter 626, Florida Statutes, the Florida Department of Financial Services (the "Department") has jurisdiction over Lawrence Marc Yucht's license and appointment.

COUNT I

4. The above general allegations are hereby realleged and fully incorporated herein by reference.



- 5. Section 626.865(2), Florida Statutes, provides, in part, that at the time of application for licensure as a public adjuster, the applicant shall file with the Department a bond executed and issued by a surety insurer authorized to transact such business in this state, in the amount of \$50,000, conditioned for the faithful performance of his or her duties as a public adjuster under the license. Such bond must be maintained unimpaired through the existence of the license and for at least one (1) year after termination of the license.
- 6. In connection with his application for licensure as a public adjuster, on May 24, 2007, Lawrence Marc Yucht filed the required bond with the Department. Old Republic Surety Company issued bond number OFL0574665.
- 7. On May 24, 2012, Old Republic Surety Company cancelled Lawrence Marc Yucht's bond number OFL0574655.
- 8. On June 5, 2012, Lawrence Marc Yucht filed the required bond with the Department. International Fidelity Insurance Company issued Lawrence Marc Yucht bond number TXFIFSU059001 on June 5, 2012.
- 9. On July 8, 2014, the Department received notice from International Fidelity Insurance Company that it would cancel the surety bond effective August 8, 2014.
- 10. On July 10, 2014, the Department issued a written notice to Lawrence Marc Yucht requesting that he provide an original replacement bond.
 - 11. Lawrence Marc Yucht did not respond to the Department's notice.
- 12. On August 8, 2014, International Fidelity Insurance Company cancelled Lawrence Marc Yucht's bond.
- 13. As of the date of the filing of this Administrative Complaint, Lawrence Marc Yucht has failed to provide the Department with proof of a replacement bond.

IT IS THEREFORE CHARGED that, Lawrence Marc Yucht has violated one or more of the following provisions of the Florida Statutes and/or the *Florida Administrative Code*, which constitutes sufficient grounds for the suspension or revocation of his license or appointment as a public adjuster in this state:

- (a) Section 626.865(2), Florida Statutes, which provides that a public adjuster shall maintain an unimpaired surety bond at all times licensed in the amount of \$50,000.
- (b) Section 626.611(1)(a), Florida Statutes, which provides that the Department shall deny, suspend, revoke, or refuse to renew or continue the license or appointment of any public adjuster if it finds that the applicant, licensee, or any principal thereof lacks one or more of the qualifications for the license or appointment as specified.
- (c) Section 626.611(1)(m), Florida Statutes, which provides that it is a violation for any applicant, agent, title agency, adjuster, customer representative, service representative, or managing general agent to willfully fail to comply with, or willfully violate, any proper order or rule of the department or any provision of this code.
- (d) Section 626.621(2), Florida Statutes, which provides that violating any provision of the Florida Insurance Code or any law applicable to the business of insurance in the course of dealing under the licensure or appointment is, in itself, a violation of law.

WHEREFORE, Lawrence Marc Yucht is hereby notified that the Chief Financial Officer, through his designee, intends to enter an order suspending or revoking any license and appointment issued to him pursuant to the Florida Insurance Code or to impose such penalties as may be provided under the provisions of sections 626.611, 626.621, 626.681, 626.691, and

626.8698, Florida Statutes, and under the other referenced sections of the Florida Statutes as set out in this Administrative Complaint.

NOTICE OF RIGHTS

Lawrence Marc Yucht has the right to request a proceeding to contest this action by the Department pursuant to sections 120.569 and 120.57, Florida Statutes, and Rule 28-106, *Florida Administrative Code*. The proceeding request must be in writing, signed by Lawrence Marc Yucht, and must be filed with the Department within twenty-one (21) days of his receipt of this notice. Completion of the attached Election of Proceeding form and a petition for an administrative hearing are required. The request must be filed with Julie Jones, DFS Agency Clerk, at the Florida Department of Financial Services, 612 Larson Building, 200 East Gaines Street, Tallahassee, Florida 32399-0333. Lawrence Marc Yucht's written response must be received by the Department no later than 5:00 p.m. on the twenty-first day after his receipt of this notice. Mailing the response on the twenty-first day will not preserve your right to a hearing.

FAILURE TO ENSURE THAT LAWRENCE MARC YUCHT'S WRITTEN RESPONSE IS RECEIVED BY THE DEPARTMENT WITHIN TWENTY-ONE (21) DAYS OF HIS RECEIPT OF THIS NOTICE WILL CONSTITUTE A WAIVER OF HIS RIGHT TO REQUEST A PROCEEDING ON THE MATTERS ALLEGED HEREIN AND A FINAL

ORDER OF SUSPENSION OR REVOCATION WILL BE ENTERED AGAINST LAWRENCE MARC YUCHT.

If Lawrence Marc Yucht requests a proceeding, he must provide information that complies with the requirements of Rule 28-106.2015, *Florida Administrative Code*. Specifically, Lawrence Marc Yucht's response must contain:

- (a) The name, address, and telephone number, and facsimile number (if any) of the respondent (for the purpose of requesting a hearing in this matter, Lawrence Marc Yucht is the "respondent").
- (b) The name, address, telephone number, facsimile number of the attorney or qualified representative of the respondent (if any) upon whom service of pleadings and other papers shall be made.
- (c) A statement requesting an administrative hearing identifying those material facts that are in dispute. If there are none, the petition must so indicate.
- (d) A statement of when the respondent received notice of the administrative complaint.
 - (e) A statement including the file number of the administrative complaint.

If a hearing of any type is requested, Lawrence Marc Yucht has the right to be represented by counsel or other qualified representative at his expense, to present evidence and argument, to call and cross-examine witnesses, and to compel the attendance of witnesses and the production of documents by subpoena.

If a proceeding is requested and there is no dispute of material fact, the provisions of section 120.57(2), Florida Statutes, apply. In this regard, Lawrence Marc Yucht may submit oral or written evidence in opposition to the action taken by the Department or a written statement

challenging the grounds upon which the Department has relied. While a hearing is normally not required in the absence of a dispute of fact, if Lawrence Marc Yucht feels that a hearing is necessary, one will be conducted in Tallahassee, Florida, or by telephonic conference call upon your request.

However, if Lawrence Marc Yucht disputes material facts which are the basis for the Department's action, he must request an adversarial proceeding pursuant to sections 120.569 and 120.57(1), Florida Statutes. These proceedings are held before a State administrative law judge of the Division of Administrative Hearings. Unless the majority of witnesses are located elsewhere, the Department will request that the hearing be conducted in Tallahassee, Florida.

Failure to follow the procedure outlined with regard to Lawrence Marc Yucht's response to this notice may result in the request being denied. All prior oral communication or correspondence in this matter shall be considered free form agency action, and no such oral communication or correspondence shall operate as a valid request for an administrative proceeding. Any request for an administrative proceeding received prior to the date of this notice shall be deemed abandoned unless timely renewed in compliance with the guidelines as set out above.

Mediation of this matter pursuant to section 120.573, Florida Statutes, is not available. No Department attorney will discuss this matter with Lawrence Marc Yucht until the response has been received by the Department.
