ORDER OF REVOCATION

THIS PROCEEDING CAME on for final agency action and the Chief Financial Officer, having considered the record, including the Administrative Complaint filed on March 12, 2015, and being fully advised in the premises, finds that:

- 1. Nicholas Carl Smith-Washington is currently licensed by the Department of Financial Services (the "Department"), pursuant to the Florida Insurance Code, as a life including variable annuity and health agent.
- 2. On March 12, 2015, the Department issued an Administrative Complaint, attached hereto as "Exhibit A," against Nicholas Carl Smith-Washington, alleging that on November 5, 2014, in the Circuit Court of the Eleventh Judicial Circuit, in and for Miami-Dade County, Florida, Case No. F14-15132, he pled guilty to one count of Possession of a Controlled Substance and one count of Attempt to Tamper with Physical Evidence, both felonies. Adjudication of guilt was withheld.
- 3. The Department notified Nicholas Carl Smith-Washington in the Administrative Complaint of the right to request a proceeding in accordance with sections 120.569 and 120.57,

Florida Statutes, and that failure to answer the Administrative Complaint or request a proceeding within twenty-one (21) days would result in the imposition of a penalty.

- 4. In accordance with section 624.310(6), Florida Statutes, after attempts at service via certified mail were unsuccessful, the Department served the Administrative Complaint upon Nicholas Carl Smith-Washington by e-mail at the e-mail address on record with the Department, with the required delivery receipt received on March 24, 2015. The e-mail, e-mail attachment (Administrative Complaint), and delivery receipt are attached hereto as "Exhibit B," and are fully incorporated herein by reference.
- 5. Nicholas Carl Smith-Washington failed to answer the Administrative Complaint or request a proceeding in accordance with sections 120.569 and 120.57, Florida Statutes.

#### **FINDINGS OF FACT**

6. The factual allegations contained in the Administrative Complaint dated March 12, 2015, which is attached hereto as Exhibit A, and fully incorporated herein by reference, are hereby adopted as the Department's Findings of Fact in this case.

#### **CONCLUSIONS OF LAW**

7. Based upon the Findings of Fact adopted herein, the Department concludes that Nicholas Carl Smith-Washington violated the specific statutes and rules charged in each count of the Administrative Complaint, attached hereto as Exhibit A, and hereby adopts the violations charged in each count of the Administrative Complaint as the Conclusions of Law in this case.

#### PENALTY IMPOSED

8. The failure of Nicholas Carl Smith-Washington to answer the Administrative Complaint or request a proceeding, taken together with the Findings of Fact and Conclusions of

Law adopted herein, constitutes grounds for the Chief Financial Officer to revoke the licenses of Nicholas Carl Smith-Washington.

#### IT IS THEREFORE ORDERED that:

- (a) All licenses, appointments and eligibility for licensure heretofore issued to Nicholas Carl Smith-Washington, within the purview of the Department, are hereby revoked.
- (b) Nicholas Carl Smith-Washington does not have the right to apply for another license or appointment under the Florida Insurance Code for a period of two (2) years from the effective date of revocation. The Department shall not thereafter grant Nicholas Carl Smith-Washington a new license or appointment or reinstate eligibility to hold such license or appointment if it finds that the circumstance or circumstances for which the license was revoked still exist or are likely to recur, or if Nicholas Carl Smith-Washington is not otherwise eligible for licensure.
- (c) During the period of revocation, and until a new license is issued, Nicholas Carl Smith-Washington shall not engage in or attempt or profess to engage in any transaction or business for which a license or appointment is required under the Florida Insurance Code or directly or indirectly own, control, or be employed in any manner by any insurance agent or agency or adjuster or adjusting firm.
- (d) Within ten (10) calendar days of the issuance of this Order of Revocation, Nicholas Carl Smith-Washington shall return all licenses issued to him pursuant to the Florida Insurance Code to the Department of Financial Services, Bureau of Licensing, 200 East Gaines Street, Tallahassee, Florida 32399-0319.

# ADMINISTRATIVE COMPLAINT

Nicholas Carl Smith-Washington 8236 Southwest 103rd Avenue Miami, Florida 33173-3906

Nicholas Carl Smith-Washington, license #P147700, is hereby notified that the Chief Financial Officer of the State of Florida has caused to be made an investigation of his activities while licensed as an insurance agent in this state, as a result of which it is alleged:

#### **GENERAL ALLEGATIONS**

- 1. Pursuant to chapter 626, Florida Statutes, Nicholas Carl Smith-Washington is currently licensed in this state as a life including variable annuity and health agent.
- 2. At all times pertinent to the dates and occurrences referred to herein, Nicholas Carl Smith-Washington was licensed in this state as a life including variable annuity and health agent.
- 3. Pursuant to chapter 626, Florida Statutes, the Florida Department of Financial Services (the "Department") has jurisdiction over his insurance license and appointments.



#### COUNT I

- 4. The above general allegations are hereby realleged and fully incorporated herein by reference.
- 5. On November 5, 2014, in the Circuit Court of the Eleventh Judicial Circuit, in and for Miami-Dade County, Florida, Case No. F14-15132, Nicholas Carl Smith-Washington pled guilty to one count of Possession of a Controlled Substance and one count of Attempt to Tamper with Physical Evidence, both felonies. Adjudication of guilt was withheld.

IT IS THEREFORE CHARGED that Nicholas Carl Smith-Washington has violated one or more of the following provisions of the Florida Statutes or Florida Administrative Code, which constitute grounds for the suspension or revocation of his license as a life including variable annuity and health agent in this state:

- (a) Section 626.611(1)(n), Florida Statutes, which provides that it is a violation for any applicant, agent, title agency, adjuster, customer representative, service representative, or managing general agent to be found guilty of or to enter a plea of guilty or nolo contendere to a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country which involves moral turpitude, without regard to whether a judgment of conviction has been entered by the court having jurisdiction of such cases.
- (b) Section 626.621(8), Florida Statutes, which provides that it is a violation to be found guilty of or to plead guilty or nolo contendere to a felony or a crime punishable by imprisonment of 1 year or more under the law of the United States of America or of any state thereof or under the law of any other country, without regard to whether a judgment of conviction has been entered by the court having jurisdiction of such cases.

WHEREFORE, Nicholas Carl Smith-Washington is hereby notified that the Chief Financial Officer intends to enter an Order revoking his license and appointments as an insurance agent or to impose such penalties as may be provided under the provisions of sections 626.611, 626.621, 626.641, 626.681, 626.691, and 626.9521, Florida Statutes, and chapter 69B-231, Florida Administrative Code, including, but not limited to, Rule 69B-231.150, Florida Administrative Code, and under the other referenced sections of the Florida Statutes as set out in this Administrative Complaint.

#### NOTICE OF RIGHTS

You have the right to request a proceeding to contest this action by the Department pursuant to sections 120.569 and 120.57, Florida Statutes, and chapter 28-106, *Florida Administrative Code*. The proceeding request must be in writing, signed by you, and must be filed with the Department within twenty-one (21) days of your receipt of this notice. Completion of the attached Election of Proceeding form and a petition for administrative hearing are required. The request must be filed with Julie Jones, DFS Agency Clerk, at the Florida Department of Financial Services, 612 Larson Building, 200 East Gaines Street, Tallahassee, Florida 32399-0390. Your written response must be received by the Department no later than 5:00 p.m. on the twenty-first day after your receipt of this notice. Mailing the response on the twenty-first day will not preserve your right to a hearing.

FAILURE TO ENSURE THAT YOUR WRITTEN RESPONSE IS RECEIVED BY THE DEPARTMENT WITHIN TWENTY-ONE (21) DAYS OF YOUR RECEIPT OF THIS NOTICE WILL CONSTITUTE A WAIVER OF YOUR RIGHT TO REQUEST A PROCEEDING ON THE MATTERS ALLEGED HEREIN AND A FINAL ORDER OF SUSPENSION OR REVOCATION WILL BE ENTERED AGAINST YOU.

If you request a proceeding, you must provide information that complies with the requirements of Rule 28-106.2015, *Florida Administrative Code*. Specifically, your response must contain:

- (a) The name, address, telephone number, and facsimile number (if any) of the respondent (for the purpose of requesting a hearing in this matter, you are the "respondent").
- (b) The name, address, telephone number, and facsimile number of the attorney or qualified representative of the respondent (if any) upon whom service of pleadings and other papers shall be made.

- (c) A statement requesting an administrative hearing identifying those material facts that are in dispute. If there are none, the petition must so indicate.
- (d) A statement of when the respondent received notice of the administrative complaint.
  - (e) A statement including the file number of the administrative complaint.

If a hearing of any type is requested, you have the right to be represented by counsel or other qualified representative at your expense, to present evidence and argument, to call and cross-examine witnesses, and to compel the attendance of witnesses and the production of documents by subpoena.

If a proceeding is requested and there is no dispute of material fact, the provisions of section 120.57(2), Florida Statutes, apply. In this regard, you may submit oral or written evidence in opposition to the action taken by the Department or a written statement challenging the grounds upon which the Department has relied. While a hearing is normally not required in the absence of a dispute of fact, if you feel that a hearing is necessary, one will be conducted in Tallahassee, Florida, or by telephonic conference call upon your request.

However, if you dispute material facts which are the basis for the Department's action, you must request an adversarial proceeding pursuant to sections 120.569 and 120.57(1), Florida Statutes. These proceedings are held before an administrative law judge of the State of Florida Division of Administrative Hearings. Unless the majority of witnesses are located elsewhere, the Department will request that the hearing be conducted in Tallahassee, Florida.

Failure to follow the procedure outlined with regard to your response to this notice may result in the request being denied. All prior oral communication or correspondence in this matter shall be considered free form agency action, and no such oral communication or correspondence

shall operate as a valid request for an administrative proceeding. Any request for an administrative proceeding received before the date of this notice shall be deemed abandoned unless timely renewed in compliance with the guidelines as set out above.

Mediation of this matter pursuant to section 120.573, Florida Statutes, is not available. No Department attorney will discuss this matter with you during the time frame in which you have to request a hearing.
